

Merchant Navy Officers Pension Fund

Recovery Plan following the 2018 valuation

This Recovery Plan has been prepared by MNOPF Trustees Limited, the Trustee of the Merchant Navy Officers Pension Fund (“the Fund”), to satisfy the requirements of Section 227 of the Pensions Act 2004, after obtaining the advice of the Scheme Actuary, Kim Farnum. This Recovery Plan has been prepared on the assumption that all contributions specified herein are paid on the relevant due date for payment.

The actuarial valuation of the Fund as at 31 March 2018 revealed a funding shortfall (technical provisions minus value of assets) of £73 million. The value as at 31 March 2018 of the outstanding deficit contributions arising from the 31 March 2012 valuation (as set out in the Recovery Plan dated 2 May 2013) and the 31 March 2009 valuation (as set out in the Recovery Plan dated 26 March 2010) was £64 million. Allowing for these produces an outstanding funding shortfall as at 31 March 2018 of £9 million.

Steps to be taken to ensure that the Statutory Funding Objective is met

To eliminate this funding shortfall, the Trustee has agreed that no contributions in addition to those arising from the 31 March 2009 and 31 March 2012 valuations will be paid to the Fund by the participating employers. Instead, expected investment returns in excess of those underlying the technical provisions will be sufficient to meet the outstanding shortfall of £9 million.

Period in which the Statutory Funding Objective should be met

The funding shortfall is expected to be eliminated by 30 September 2023. This expectation is based on the assumptions underlying the technical provisions with changes as set out below:

- The return on Fund assets during the period from the valuation date to 30 September 2023 is 0.1% per annum in excess of the average discount rate used in the calculation of the technical provisions.
